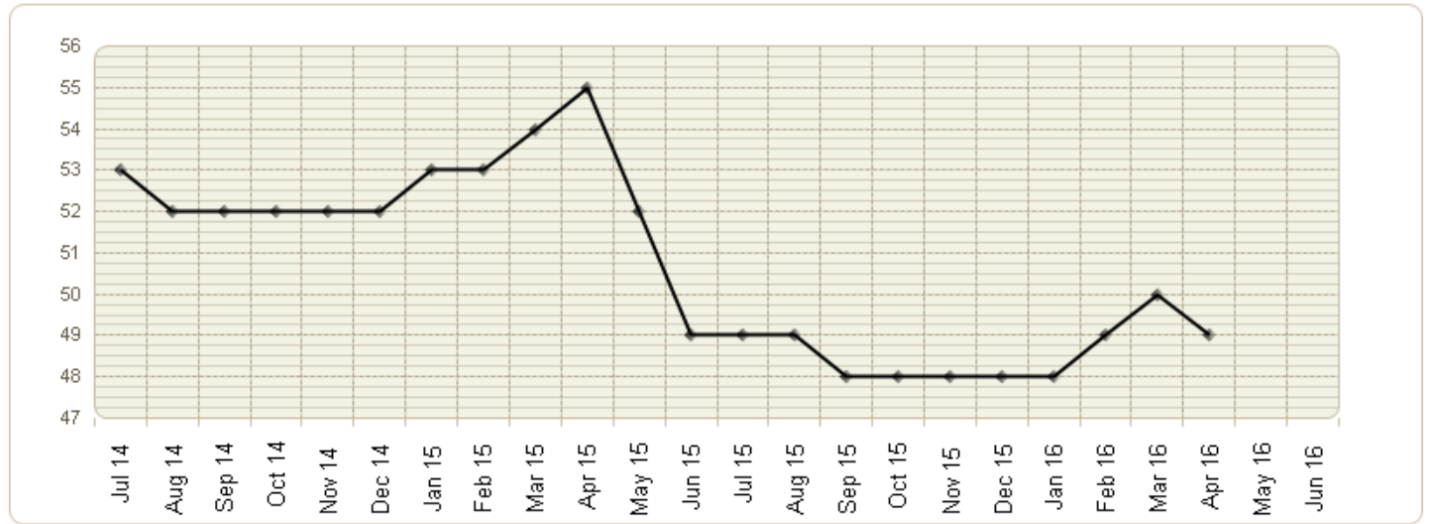

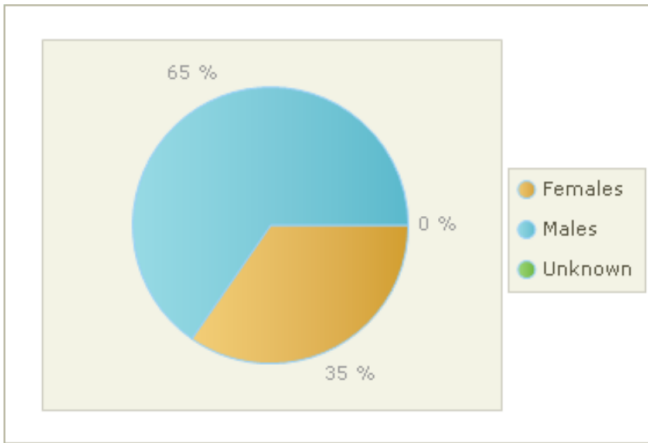

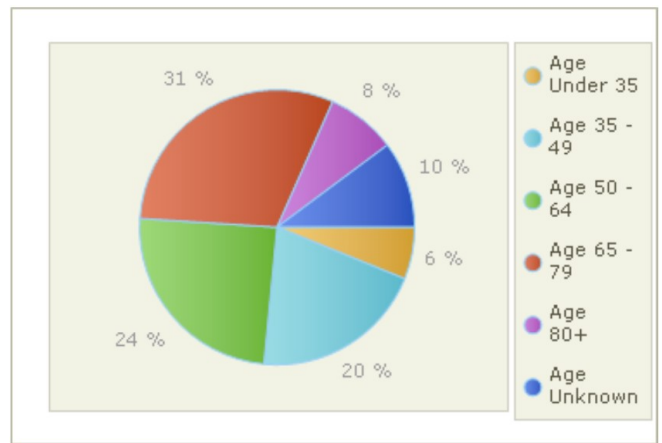

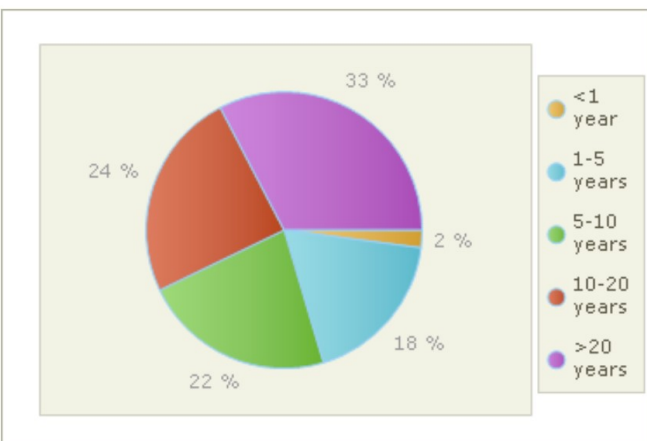
Gender Distribution Report



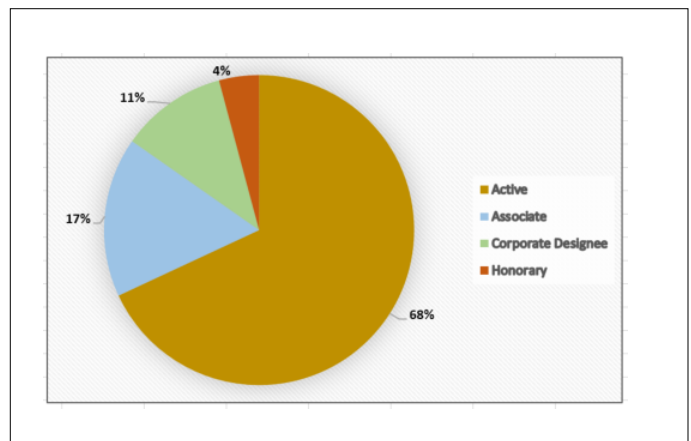
Age Distribution Report

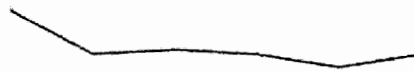
